a) Changing the Drug-Drug interactions permissions

We will need a “test” user (Physician), with no secondary menus:

1. Give the menu “EVE” Test Physician at Test time and allow him to edit.
2. If he is going to edit from “critical” to “significant”, he will also need programmer access “@”
